What is the Horizon Dental Choice Plan?

The Horizon Dental Choice (HDC) Plan covers 100 percent of all eligible Preventive and Basic services with no copayments, no maximums or deductibles when receiving those services from your primary Horizon Dental Choice dentist. The HDC Plan also covers 50 percent of charges for all eligible major and speciality services. The key to HDC is that care must be coordinated through the participating HDC dentist that you select to use as your primary dentist.

Here's an example of how the Horizon Dental Choice Plan works:

Service	Member Pays using HDC dentist	Member Pays using out-of-network dentist
Comprehensive Oral Exam [a Preventive service]	0% of charges	100% of charges
Simple extraction [a Basic service]	0% of charges	100% of charges
Crown [a Major service]	50% of charges	100% of charges

How does it work?

It's easy! Select a participating Horizon Dental Choice dentist (located in New Jersey only) as your primary dentist. Refer to our directory of participating dentists or visit our user-friendly Web site, www.horizonblue.com, and find the names and addresses of participating dentists, detailed door-to-door directions and a street map. **Employees who select Horizon Dental Choice must use the Horizon Dental Choice dentist they selected as their primary dentist for benefits to be considered eligible. There is no out-of-network benefit for Horizon Dental Choice.**

How do I enroll in the Horizon Dental Choice Plan?

It's simple! To enroll in the plan, simply check the Horizon Dental Choice Plan box and indicate the Dentist Office ID number of your primary dentist on your application. If you or a dependent have dental work in progress, you must wait until the work is complete before you can enroll.

If you don't apply for coverage when first eligible, you must satisfy an 18-month waiting period before you again become eligible to enroll in this plan.
